



DEAD THEOLOGIAN SOCIETY © CHAPTER AGREEMENT

The Dead Theologians Society (hereinafter referred to as DTS) is 501(c) (3) not-for-profit Corporation organized under the laws of the State of Ohio. In consideration of the mutual covenants of the parties set forth herein, and for other good and valuable consideration, receipt of which is hereby acknowledged, DTS and the DTS Chapter agree as follows:

DTS agrees to allow the DTS Chapter the use of the name and logo of the Dead Theologians Society and its meeting format for a period of one (1) year, renewable on a yearly basis, in return for an initial Membership Fee of five hundred dollars (\$500) and a yearly renewable Membership Dues of two hundred and fifty dollars (\$250). It is expressly understood and agreed that any DTS Chapter that forms is not in any manner a part of the national Dead Theologians Society organization, nor is not in any manner an agent of DTS, nor is the Chapter authorized or empowered to conduct business under the name of, or for the account of, DTS, or to make any promise, warrant or representation on DTS's behalf with respect to any product or service of DTS.

The DTS chapter hereby agrees to follow the prescribed policies of the Dead Theologians Society as outlined in the official DTS Policies. The DTS chapter also hereby agrees to follow the prescribed meeting format of the Dead Theologians Society as outlined in the official DTS Manual. If the DTS Chapter fails to comply with any provision of this Agreement, it will have its charter revoked and forfeit all rights to use the name and logo of the Dead Theologians Society. The DTS Chapter hereby agrees to use only Materials approved by the national Dead Theologians Society and its Board of Directors in any and all of its DTS Chapter activities. "Materials" include DTS hoods, manuals, chaplets, and any other such items that make use of the name Dead Theologians Society, its logo or any other similar mark or device. The name Dead Theologians Society and its logo are copyrighted and is a registered service mark. Any use of the name or logo without the express written consent of the national Dead Theologians Society and its Board of Directors is strictly prohibited. The DTS Chapter hereby also agrees to only purchase such Materials for use in any and all of its DTS Chapter activities solely from the national Dead Theologians Society.

The DTS Chapter hereby also agrees to indemnify and hold the Dead Theologians Society, its Board of Directors, or any of its employees or agents, free and harmless from any obligations, costs, claims, judgments, attorneys' fees, and attachments arising from or growing out of any and all activities on the part of the Chapter, or on the part of the members, agents or employees of the Chapter, whether or not such conduct constituted willful misconduct or gross negligence on the part of the Chapter, or its members, agents or employees. In addition, the DTS Chapter agrees that it will pay all costs, monetary judgments and/or attorneys' fees, when due, arising from any such claims.
